RESCISSION OF EMERGENCY AUTHORIZATION SFWMD ORDERS NO. 2024-073-DAO, 2024-074-DAO, AND 2024-075-DAO, REPAIRS, REPLACEMENT, RESTORATION, PUMPING, PROCUREMENT OF GOODS AND SERVICES, AND OTHER MEASURES MADE NECESSARY BY HURRICANE MILTON

ORDER RESCINDING SFWMD ORDERS NO. 2024-073-DAO, 2024-074-DAO, AND 2024-075-DAO ISSUED IN RESPONSE TO HURRICANE MILTON

The South Florida Water Management District ("District") enters this Order rescinding SFWMD Orders No. 2024-073-DAO, 2024-074-DAO, and 2024-075-DAO ("Emergency Final Orders") under sections 120.569(2)(n), 252.46, 373.119(2), and 373.439, Florida Statutes. The Emergency Final Orders authorized repairs, replacement. restoration, pumping, procurement of goods and services, and other emergency measures to address impacts caused by Hurricane Milton.

FINDINGS OF FACT

- 1. Governor DeSantis issued Executive Orders 24-214 and 24-215 on October 5 and 6, 2024, respectively, declaring a state of emergency based upon the serious threat to the public health, safety, and welfare posed by Hurricane Milton.
- 2. On October 6, 2024, the District issued SFWMD Orders No. 2024-073-DAO, 2024-074-DAO, and 2024-075-DAO, authorizing repairs, replacement, restoration, pumping, procurement of goods and services, and other emergency measures required due to the threat of Hurricane Milton.
 - 3. Conditions within the affected areas of the District have improved such that

a serious threat to the public health, safety, and welfare no longer exists.

4. Due to the improved conditions, the Emergency Final Orders are no longer

necessary.

CONCLUSIONS OF LAW

4. Pursuant to sections 120.569(2)(n), 252.46, 373.119(2), and 373.439,

Florida Statutes, the District's Executive Director, with the Governing Board's

concurrence, is authorized to require actions be taken "[w]hen necessary during

emergency conditions such as floods, severe weather events, or wildfire for public safety

and the protection of natural resources."

5. The Executive Director has the authority, with Governing Board

concurrence, to rescind the Emergency Final Orders when conditions improve such that

the orders are no longer needed.

ORDER

THEREFORE IT IS ORDERED that:

6. SFWMD Orders No. 2024-073-DAO, 2024-074-DAO, and 2024-075-DAO

are rescinded.

7. This Order is effective immediately upon execution.
